## Yaw to Unveil Pennsylvania Skill Game Regulation Legislation

**Sen. Gene Yaw (R-Lycoming),** announced has that he will be unveiling legislation that will establish a regulatory framework and taxing structure on skill video games in the Commonwealth. In a memo circulated to Senate members, Yaw explained the legislation could generate an estimated \$300 million in immediate annual tax revenue.

"Pennsylvania's skill game terminals are manufactured right here in Lycoming County and the finished products exist in fraternal clubs, veterans' organizations and taverns, as well as other local businesses throughout the Commonwealth," Sen. Yaw said. "Skill games are a piece of the small business economy in our state, and it's time we recognize the benefits of this emerging industry and offer regulatory support, so that we can ensure it flourishes - safely and responsibly." Under the proposed measure, all games will be required to be connected to a terminal collection and control system that allows the Commonwealth to monitor all transactions and ensure that all taxes are accrued and paid. Additionally, the legislation will strengthen penalties for those who operate unlicensed and illegal games and gambling devices. Yaw said this legislation, which will help rid the market of illegal games and provide the state with additional tax revenue while supporting small businesses, is expected to be formally introduced later this month.

## The following bills of interest were introduced and acted upon in the General Assembly since the last Bulletin.

<u>HB 38</u> RE: Rauwolf liquor licenses (by Rep. Marci Mustello, et al) Amends Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for applications for hotel, restaurant and club liquor licenses and for application for distributors', addresses

Rauwolf liquor licenses.

## <u>HB 39</u> RE: <u>Brewery Fairness in Licensing & Storage</u> (by Rep. Marci Mustello, et al)

Amends Liquor Code, in Pennsylvania Liquor Stores, further providing for sales by Pennsylvania Liquor Stores; and, in licenses and regulations and liquor, alcohol and malt and brewed beverages. Allows local breweries the 10% discount, and increases the number of locations for storage from two to five locations, to put them on par with limited wineries and distilleries.

### <u>HB 41</u> RE: <u>Safe Online Ordering and Local Delivery of Beer and Wine</u> (by Rep. Marci Mustello, et al)

Amends Liquor Code, in distilleries, wineries, bonded warehouses, bailees for hire and transporters for hire, providing for transporters

for hire, permitting beer and wine delivery by WEP licensees and third parties who hold LCB-licensed Transporter-for-Hire permits through an on-line ordering and delivery platforms that they establish. It would also grant these rights to beer distributors and enhance the state's online retail ordering process by offering another mechanism for local delivery from state stores.

HB 48 Wine Shipments (by Rep. Rob Mercuri, et al)

Amends the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for shipment of wine.

## HB 86 RE: <u>Cleaning Up Eligibility For Special Occasion Permits In The</u> Liquor Code (by Rep. Abby Major, et al)

Amends the Liquor Code, in preliminary provisions, further providing for definitions.

## <u>HB 107</u> RE: <u>Allowing Limited Wineries to Partner with BYOBs</u> (by Rep. Joe Ciresi, et al)

Amends the Liquor Code, in distilleries, wineries, bonded warehouses, bailees for hire and transporters for hire, further providing for limited wineries. Provides holders of a limited winery license may obtain an off-premises wine catering permit to use off the licensed premises in partnership with an otherwise unlicensed BYOB restaurant where the licensee may sell wine, by the glass, open bottle or other container and in any mixture together with food, for consumption on those premises. Defines BYOB restaurant as a restaurant, eating place or caf not licensed by the Liquor Control Board that offers on-premises dining, has a valid health permit and allows patrons who are at least 21 years of age to bring wine, beer or spirits to consume while dining at the premises.

## <u>HB 186</u> RE: <u>Extending State Tax Relief to all Uniformed Services</u> (by Rep. Dan Miller, et al)

Amends the Tax Reform Code, in personal income tax, further providing for classes of income by exempting income derived from the United States government for active duty outside the commonwealth of Pennsylvania as a member of the United States Public Health Service or the National Oceanic and Atmospheric Administration.

HB 221 RE: Use of Minors for Enforcement (by Rep. Brian Smith, et al) Amends the Liquor Code, in Pennsylvania Liquor Control Board, further providing for enforcement. Clarifies enforcements expire December 31, 2027. **PFFSO Position: Neutral** 

Introduced and referred to House Liquor Control Committee, 3/17/2023

HB 371 RE: Previously Unlicensed Location (by Rep. Mary Isaacson, et al)

Amends the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, establishing that "previously unlicensed location" means a location that has never held a retail liquor license, importing distributor license or distributor license or one which previously held a retail liquor, importing distributor license or distributor license which was not used for a subsequent non-licenserelated purpose for three years and including previously unlicensed locations throughout the Liquor Code.

<u>HB 448</u> RE: Sales tax Exclusion for Firefighting Equipment (by Rep. Brandon Markosek, et al)

Amends the Tax Reform Code, in sales and use tax, further providing for exclusions from tax on the sale at retail or use of firefighting equipment when purchased by an individual who is a paid or volunteer firefighter using personal funds.

## HB 733 RE: Esports (by Rep. Ed Neilson, et al)

Amends Title 4 (Amusements), in sports wagering, adding a definition for "esports" to include a competition involving video games in which the players are 18 years of age or older and compete against each other and the dominant element determining the results is the relative skill of the players.

HB 829 RE: Interlocking Businesses (by Rep. Matthew Gergely, et al) Amends the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for interlocking business prohibited and for unlawful acts relative to liquor, malt and brewed beverages and licensees. Provides that a person with ownership interest in a brewery license shall not prohibit the person from being employed by an entity that holds a hotel, restaurant, eating place or **club license** if the person is not employed as a manager. Further provides it is unlawful for any hotel, restaurant or club liquor licensee, or any malt or brewed beverage licensee, or any officer or manager of such licensee to be at the same time employed, directly or indirectly, by any distributor, importing distributor, manufacturer, importer or vendor licensee or any out of state manufacturer. **PFFSO Position: Neutral** 

## Introduced and referred to House Liquor Control Committee, 4/3/2023

HB 894 RE: Truck Stop VGTs (by Rep. Seth Grove, et al)

Amends Title 4 (Amusements), in general provisions relating to video gaming, changing the definition of truck stop establishment to remove provisions the premises must have sold an average of 50,000 gallons of diesel or biodiesel fuel per month for the previous 12 months or is projected to sell that amount for the next 12 months.

## <u>HB 955</u> RE: <u>Update to our Current Liquor Laws Regarding Brew-</u> eries/Distilleries (by Rep. Jonathan Fritz, et al)

Amends the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for breweries; and, in distilleries, wineries, bonded warehouses, bailees for hire and transporters for hire. This legislation will allow a single entity to hold and operate a brewery license and a distillery license at the same location.

## PFFSO Position: Neutral Filed, 4/17/2023

SB 102 RE: Sales Tax on Fire Equipment (by Sen. Pat Stefano, et al) Amends the Tax Reform Code excluding from the sales and use tax the sale at retail or use of accessory equipment, communications equipment or protective equipment when purchased by a paid or volunteer firefighter or a member of the special fire police who uses personal funds and, at the time of purchase, provided identification showing his or her status as a firefighter or a member of the special fire police. This exclusion shall be included on any sales tax exclusion list made available to retailers and shall not apply if the cost of the accessory equipment, communications equipment or protective equipment is paid by the firefighter's fire company or any other entity.

SB 117 RE: Age-verification devices (by Sen. Judy Ward, et al) Amends the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, providing that the display, sale, storage and purchase of wine and malt brewed beverages in any area of the business which is connected to the licensed premises by an interior connection or connections approved by the board. Provides that unless presented with a valid armed forces of the United States identification card, a wine expanded permit holder shall utilize a transaction scan device to verify the age of an individual who appears to be under thirty-five years of age at the point of sale. Further provides that a salesclerk who is under eighteen years of age may operate a register if the salesclerk is presented with wine or malt or brewed beverages to be purchased by a customer and obtains the assistance of an employee who is at least 18 years of age and the sale otherwise conforms to the requirements under the section.

## <u>SB 129</u> RE: Spirits Sales (by Sen. Pat Stefano, et al)

Amends the Liquor Code, in preliminary provisions, further providing for definitions by inserting a definition for spirits. In licenses and regulations and liquor, alcohol and malt and brewed beverages, providing for spirit expanded permits by stating the Pennsylvania Liquor Control Board shall issue a spirit expanded permit to a person holding and possessing a valid restaurant liquor license or hotel liquor license if adhering to certain guidelines. Defines transaction scan device. Provides the initial application fee for a spirit expanded permit shall total \$2,000, and an annual renewal fee for a spirit expanded permit shall be equal to two percent of the cost of spirits purchased for offpremises consumption. All fees paid to the board shall be deposited into the State Treasury. Permit holders may sell for off-premises transactions up to 3,000 mL of spirits in a single transaction. Permit holders shall comply with existing state law, may not sell a spirit product for off-premises consumption at a price less than the licensee's purchase price from the board of the spirit product, and may not sell a private

<u>SB 131</u> RE: Transaction Scan Devices (by Sen. Patrick Stefano, et al) Amends the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for wine expanded permits by clarifying transaction scan devices to verify age shall be used at the point of sale or the point of delivery of wine. **PFFSO Position: Neutral** 

## Introduced and referred to Senate Law and Justice Committee, 1/19/2023

<u>SB 148</u> RE: Volunteer Firefighter Tax Credit (by Sen. Michele Brooks, et al)

Amends the Tax Reform Code, providing for volunteer firefighter tax credit. Provides a taxpayer may claim a tax credit against the qualified tax liability of the taxpayer by submitting an application for the tax credit in a manner required by the Department of Revenue (DOR), providing for information required in the application and procedures. Clarifies taxpayers that are active volunteer firefighters that meet the eligibility requirements will receive a tax credit. Prohibits carryover and carryback of an unused tax credit. Provides for selfcertification. Directs DOR to adopt guidelines for administration. Provides that a tax credit granted may apply to the tax liability of the spouse of an eligible taxpayer if both the eligible taxpayer and spouse report income on a joint income tax return. Directs DOR to submit a report on the tax credit to the General Assembly. Penalizes taxpayers claiming a credit while failing to meet the credit, directing them to repay the full amount of the tax credit and interest. **PFFSO Position: Support**

## <u>SB 177</u> RE: Property Tax Exemption for Veterans (by Sen. Camera Bartolotta, et al)

A Joint Resolution proposing an amendment to the Pennsylvania Constitution, in taxation and finance, further providing for exemptions and special provisions by allowing an exemption for a portion, instead of all, of real estate taxes for veterans that have a permanent disability of 50 percent or greater. The percentage of exemption from real property taxes shall be in direct proportion to the percentage of disability. Constitutional amendments require approval in two consecutive legislative sessions and then approval by the voters through a referendum.

SB 236 RE: Disaster Declarations (by Sen. Michele Brooks, et al) Amends Title 35 (Health and Safety), in commonwealth services, adding a new subsection providing when a formal disaster declaration is made, the commonwealth must adopt the U.S. Department of Homeland Security Cybersecurity and Infrastructure Security Agency's Essential Critical Infrastructure Workers Guidance Version 4.0 to identify the base level of essential business operations and services. Also allows the commonwealth to adopt a broader list of essential business operations and services than what is included in the guidance.

<u>SB 248</u> RE: Veteran-owned Business Loan Guarantee Program (by Sen. Doug Mastriano, et al)

Amends Title 64 (Public Authorities and Quasi-Public Corporations), in Commonwealth Financing Authority, establishing the Veteranowned Business Loan Guarantee Program. Provides for application requirements, including name and address, a statement defining the service area of the commercial lending institution, a statement describing the commercial lending activities and how the commercial lending institution intends to expand the activities, and any other information required by the board. Adds the procedure for enrollment approval and the requirements for the master guarantee agreement, including the procedure for the submission of a claim for payment by the commercial lending institution, a requirement that a percentage of any money recovered by the commercial lending institution and periodic reporting requirements by the commercial lending institution regarding itself and the loans. Provides the requirements for an application for guarantee by the commercial lending institution enrolled in the program, including name, number of projected new or retained employees, a copy of the borrower's last two years of financial statements, a statement regarding the purpose of the loan, any other information required by the board. Provides for the application review process by the board and the limitations for a guarantee, including it may not exceed 50 percent of the outstanding principal amount of a loan and it may not exceed \$250,000 for any one loan. Provides for the allocation of the sum of \$5 million from the Second Stage Loan Program for the loan guarantees.

## SB 360 RE: Club Six Packs (by Sen. Judy Ward, et al)

Amends the Liquor Code, further providing for sales by liquor licensees and restrictions by specifying no club licensee or its servants, agents, or employees may sell malt or brewed beverages for offpremises consumption between the hours of 2:00 a.m. and 7:00 a.m. on any day. Further provides for unlawful acts relative to malt or brewed beverages and licensees, specifying no club licensee or its servants, agents, or employees may sell malt or brewed beverages for off-premises consumption between the hours of 2:00 a.m. and 7:00 a.m. on any day.

## <u>SB 365</u> RE: <u>Workers' Compensation for First Responders With</u> <u>PTSI</u> (by Sen. Camera Bartolotta, et al)

Amends the Workers' Compensation Act, in interpretation and definitions, further providing for definitions by inserting definitions for first responder and post-traumatic stress injury. In liability and compensation, further providing for compensation for post-traumatic stress injury by clarifying a post-traumatic stress injury suffered by a first responder shall be determined if there is evidence the injury resulted from normal or abnormal working conditions and was sustained in the individual's employment as a first responder; the injury shall be examined and diagnosed by a psychologist or psychiatrist; an injury claim must be filed within three years of the date of diagnosis' when an injury is diagnosed after the last date of employment, the act shall not prohibit a claim against an employer at the time of the direct exposure to the traumatic event that cause the injury. Amendments to the act shall apply to claims filed on or after the effective date.

<u>SB 367</u> RE: Benefits to Officers' Families (by Sen. Judy Ward, et al) Amends the Police Officer, Firefighter, Correction Employee and National Guard Member Child Beneficiary Education Act, extending benefits to certain surviving spouses, and providing for the Postsecondary Educational Gratuity Program. Establishes the Postsecondary Educational Gratuity Program for children or surviving spouses of police officers, firefighters, emergency medical services personnel, correction employees, state parole agents, county officers, sheriffs, deputy sheriffs and National Guard members and certain individuals on active military duty that are residents of Pennsylvania and killed while acting in the performance of their duties. Provides for circumstances in which emergency medical services personnel, state parole agents and county officers would qualify for dying in the performance of their duties.

<u>SB 368</u> RE: Volunteer Emergency Service Tuition Credit Program Act (by Sen. Judy Ward, et al)

Establishes a tuition credit program for members of volunteer fire companies, ambulance services, rescue squads and their dependent children and spouses if they're in good standing and the dependent children and spouse are eligible to enroll in a postsecondary course on a tuition-credit basis in a community college. Limits the amount to \$600 per year, limiting it from exceeding the maximum of \$2,400 over a four-year service period. Allows for tuition credit to courses if available space permits and the tuition-paying students constitute the minimum number for the course. Directs the volunteer to agree to serve as a member of a volunteer fire company, ambulance service or rescue squad for a minimum of four years and sign an agreement pledging four years of service in exchange for the tuition credit. Provides that the volunteer, dependent child or spouse shall provide the community college with a sworn or official statement of fact by the commissioner attesting the volunteer performed the service required for tuition credit. Provides for issuance of certificate of authorization to the volunteer, dependent child or spouse to present to the community college, stating that the volunteer, dependent child or spouse is a member in good standing. Directs the Office of the State Fire Commissioner to develop procedures and forms as necessary.

<u>SB 430</u> RE: 50% Proceeds Rule (by Sen. Dan Laughlin, et al) Amends Local Option Small Games of Chance Act, in club licensees, further providing for distribution of proceeds to change 60 percent to 50 percent. The bill is applicable to calendar years starting after December 31, 2023.

<u>SB 504</u> RE: Association Health Plans (by Sen. Jim Brewster, et al) Amends Title 40 (Insurance), in regulation of insurers and related persons generally, establishing Chapter 41 regarding association health plans. The bill provides policy requirements for associations offering health insurance and insurer requirements regarding the health insurance policy.
